Guide for creating a Multi-State Resale Certificate with out-of-state State Tax ID



In this example it is shown how to create and upload a Multi-State Resale Certificate using an out-of-state State Tax ID for some of the states.

The same California Sales Tax ID number will be used to apply for exemption in California, Nevada, Missouri, Michigan, Maine and Colorado.

Due to a technical limitation it is not possible to create an MTC form with out-of-state ID numbers with our Resale Certificate Wizard.

Therefore, please download the <u>empty MTC form</u> - it can be filled out digitally, or it can be printed out and scanned.

Please note that while many states listed on MTC form will accept out-of state registration to be used next to the state initials, some states require that state-specific tax ID is used. If you are not registered in these states, you cannot claim resale exemption for these states - more details in the next step.

The marked states won't accept a resale certificate that uses a Sales Tax ID number from another state.
